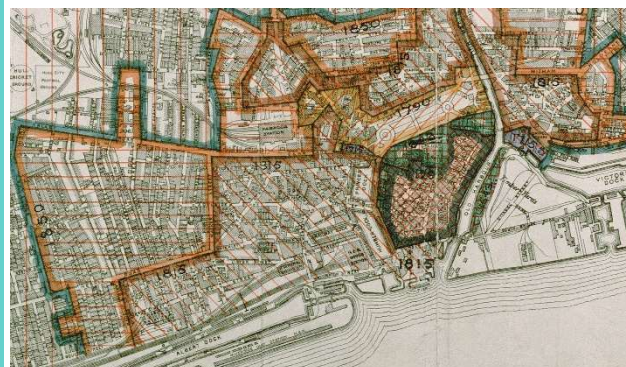

### Introduction

Hull History Centre is home to the Hull City Archives, the Hull Local Studies Library and the University of Hull archives. The material held ranges from paper to parchment and includes books, maps, plans, photographs and newspapers. Depending on the format, these can be viewed in our search room or on microfilm, whilst many of our Local Studies library books can be borrowed if you are a member of Hull Libraries.

Trying to find what you are looking for can be daunting, so a number of guides have been created to help you.

This guide relates to the records useful in researching the city's changing boundaries over the years.

Many of the books in the list can be borrowed from our library if you are a member of Hull libraries. If not, you can join when you visit the Centre or online.

The items listed within the City Archives, Local Studies and Hull University Archives relate to records found within our collections not necessarily wholly relating to how the boundaries have changed, but which may prove useful to your research.

This list is not exhaustive and our on-line catalogue may also help you to find what you are looking for. Type in words like 'boundary extension' into the search engine and it will bring up any records or books we hold relating to the subject.

In addition, the Hull Local Studies Library has an extensive number of card index references for the various boundary debates within the local press and in particular, the Hull Daily Mail. These can produce many useful references especially for the periods between 1964-1966 and 1992-1993.
