# INTRODUCTION

### Politics at Hull History Centre

Hull History Centre holds unique archival and rare book material for the study of a wide array of political themes. The Centre is home to Hull University Archives, Hull City Archives and Hull Local Studies Library.

### University of Hull Archives

In 1928 Harold Laski donated a speech by John Stuart Mill to the library at University College Hull. This donation was to be the start of a manuscript collection within the library. During the 1960s and 1970s, with the support of the then librarian, Philip Larkin, John Saville, an Economic and Social History Professor, encouraged various campaign, left-wing, labour and trade union related groups, both local and national, to deposit their papers. The University Archives' reputation in this area continues to attract similar deposits.

### **Hull City Archives**


The process of governing Hull has left almost a millennium of documentary evidence, including minutes, reports, letters, charters and deeds. This evidence reflects, from the official perspective, the changes, events and administrative reorganisations which have shaped Hull's political landscape. Subjects covered include regulation of wages, appointment of officials, crime and punishment. licensing of public houses, and enforcement of customs and excise measures. In addition, material created by local public bodies, societies and businesses has been added to the official record. With these additions, the collections have grown to represent both official and non-official perspectives on local politics.

### **Hull Local Studies Library**

Originally part of the city's Central Library Service, Local Studies Library collections consist mostly of rare printed and published material, although they do include some archival material. Local Studies collections relate to the city, and to the people, businesses and organisations to which it has been home. Subjects covered reflect the changing political and social landscape of the city across the centuries, and help to provide context to the evidence recorded in both City and University archival material.

# **ACCESS**



Material other than that listed in this guide might exist for any given subject within larger collections. For example, subject files on a whole host of topics can often be found within a politician's papers.





# **HELPFUL ADVICE: KEYWORDS**

Having a targeted approach to searching catalogues is vital in order to identify as much information as possible. It can be helpful to draw up a list of similes around key subject areas, to ensure that descriptive variance is accounted for when searching.

Using variant name spellings for individuals and places of interest might also return more results. If searching for events, make sure to incorporate the various words used to refer to individual events. In the case of individuals, it can be helpful to begin with surnames and first names, then widen your search to include surnames and an initial, and finally surnames only.

Remember to use contextual details and dates within descriptions to help you to identify whether something might be relevant.

Finding Aid: Local Studies Card Catalogue Cards arranged by author and title. Individual cards give reference numbers for Local Studies library books, which are not yet on the online catalogue.

Finding Aid: City Council Index Cards
Cards arranged by surname and by street
name. Individual cards give references to
occurrence of individuals and streets within
the official records of the city council. Mostly
relates to criminal records, planning and
building regulations, and health department
photographs. This index can be accessed in
the History Centre searchroom.

# **CIVIL RIGHTS**

The subject of civil rights is strongly supported by material from collections in our holdings. Particular strengths are 20th century British campaign groups, miscarriages of justice, gender rights, and police action.

### SPOTLIGHT COLLECTION

Christopher Mullin MP, 1970-2010 [U DMU]

**Fact:** Before becoming an MP, Mullin studied law and then worked as a foreign correspondent. During the 1970s he investigated, wrote on, and lobbied for cases in which there appeared to have been miscarriages of justices.

**Content:** Subject files; articles and drafts; press cuttings; audio recordings; statements; copy court papers.

**Subjects Covered:** Birmingham Six; Guildford Four; Maguire Seven; Carl Bridgewater; Judith Ward.

Parity, 1953-2017 [U DPY]

Fact: The group was formed in 1986 to campaign for equal state pension ages. Its remit expanded in the following years to encompass the fight for equal statutory rights between men and women

**Content:** Minutes; correspondence; publicity material; campaign files; conference papers.

Subjects Covered: Meetings; pension age; widows benefit; National Insurance; prescription charges; boys education; bus passes; winter fuel; domestic violence; homicides; rape; circumcision; sex bias in public funding; gender pay gap, men's health.

Julia Varley, 1886-1977 [U DJV]


**Fact:** Born in 1871, Varley was a notable female trade unionist, who served on various bodies, including the General Council of the Trades Union Congress.

**Content:** Correspondence; press cuttings; articles; poems; photographs; ephemeral material such as invitations.

**Subjects Covered:** Suffragettes; Women's Social and Political Union; Industrial Welfare Society; trade unionism; imprisonment of suffragettes and suffragists.

### SPOTLIGHT COLLECTION


Robin Page Arnott, 1880-1979 [U DAR]



# SPOTLIGHT COLLECTION

International Marxist Group, 1955-1976 [U DMG]

**Fact:** The group emerged in the 1960s, with Trotskyist and revolutionary aims. It was responsible for the publication of the journal, 'The Week', and wished to establish government based on direct democratic control by the people.

**Content:** Files containing minutes, balance sheets, notes newsletters, bulletins, etc.

**Subjects Covered:** NHS; armed forces; overseas work (Africa, Indochina, Vietnam); conferences; world congress; trade union work; political events.

# **COOPERATIVE MOVEMENT**

For anyone interested in the history of the Cooperative movement, there are a number of significant collections within our holdings. Strengths include women's cooperation during the 20th century.

### SPOTLIGHT COLLECTION

The Cooperative Production Federation, 1896-1968 [U DCF]


**Fact:** Formed in 1882 as part of the Cooperative Movement, the Federation sought to bring together 15 local producer-owned societies to help them find capital and markets for their goods. Its work was overtaken by the establishment in 1971 of the Industrial Common Ownership Movement

**Content:** Minutes; press cuttings; financial papers.

**Subjects Covered:** Meetings; footwear commodity committee; Stanton Memorial Scholarship committee.



# National Cooperative Women's Guild, 1886-1971 [U DCW]

**Fact:** The Guild has its origins in the Woman's League for the Spread of Cooperation, formed in 1883 by Alice Acland and Mary Lawrenson. Its work involved the promotion of cooperative principles, and the betterment of the political, legal and social position of women through education, publications and campaigning.

**Content:** Minutes; annual reports; AGM and congress papers; rules; photographs; printed material.

**Subjects Covered:** Meetings; early years and formation; talks; congresses; overseas visitors; events and activities.

### SPOTLIGHT COLLECTION

East Yorkshire Friendly Society, 1789-1990 [U DFR]

**Fact:** In 19th Century East Yorkshire there were over 350 Friendly Societies. This artificial collection brings together material from various branches.

**Content:** Rule books; branch records; directories; diaries; histories; placards.

# ECOLOGICAL AND ENVIRONMENTAL POLITICS

A small but interesting area of our holdings relates to ecological and environmental politics. Strengths include animal rights and preservation, along with global environmental sustainability.

### SPOTLIGHT COLLECTION

British Union for the Abolition of Vivisection, 1865-1996 [U DBV]

**Fact:** The first anti-vivisection societies started appearing in 1875. Miss Frances Power Cobbe founded the BUAV in 1898 to fight for the complete abolition, not just restriction, of the practice.

**Content:** Press cuttings; periodicals; campaign papers; subject files.


# SPOTLIGHT COLLECTION

**Fact:** The GEF was established in 1991 to assist in the protection of the global environment, and to promote sustainable development, through the provision of grants and funding to various projects.

**Content:** Files containing minutes, reports, working papers, statements.

# SEA BIRDS'

PRESERVATION BILL, 1869.

NOTICE IS HEREBY GIVEN, that any Person killing, wounding, or taking, or attempting to kill, wound, or take, any Sea Bird, between the 1st day of April and the 1st day of Angust, is liable to a penalty of £1, recoverable before any Justice of the Peace, for each Sea Bird so killed, wounded, or taken. And one-half of such penalty is payable to the Informer.

### SPOTLIGHT COLLECTION

Association for the Protection of Sea Birds, 1834-2000 [U DSB]

**Fact:** Founded by Reverend Henry Frederick Barnes-Lawrence and Reverend Francis Orpen Morris in 1868, the group campaigned for the protection of sea birds from hunting and egg collecting. Their early work culminated in the passing of the Sea Birds Preservation Act in June 1869.

**Content:** Mostly correspondence, but includes limited publicity material and photographs



# SPOTLIGHT COLLECTION

### Herbert Colin Creighton, 1973-1991 [U DX185]

**Fact:** Creighton was a Sociology lecturer at the University of Hull, and was a committee member of the Hull Chile Solidarity Campaign, and also of the Hull Latin American Campaign.

**Content:** Subject files containing flyers, posters, minutes, circulars, newsletters and correspondence.

Subjects Covered: Chile Solidarity Campaign; Chile Committee for Human Rights; El Salvador Committee for Human Rights; El Salvador Solidarity Campaign; Hull Latin American Committee.

Human rights do not grow on trees, nor are they contained in a divine cornucopia from which they may rain on our undeserving heads.

Human rights are entirely dependent on the will and the concerns of other people to grant those rights. Some of the ancient Greek philosophers expressed the view that justice was nothing more than the will of the man with the power to enforce it. This did not mean that justice was devalued, it only observed the pertinent truth that the value of justice is dependent on the power of the man who will support it, so it is also true that the value of the human rights we talk about is dependent entirely on the will and concerns of men. In this context I believe "concerns" to be the keyword.

# Joint Council for the Welfare of Immigrants, 1938-1993 [U DJC]

**Fact:** The council was founded on 23 September 1967 at the Dominion Cinema in Southall, by 240 people representing a variety of immigrant groups in the UK. The council's activities have included the provision of assistance to persons immigrating to the UK, and also the undertaking of general campaign work.

**Content:** Minutes; reports; financial records; administrative papers; case papers; campaign files; subject files; periodicals pamphlets; leaflets.

**Subjects Covered:** Immigrants Aid Trust; individual cases; East Africa; prisons; political asylum; ports.

### SPOTLIGHT COLLECTION

### John Platts-Mills, 1927-2001 [U DPM]

**Fact:** Born 4 October 1906 in New Zealand, Platts-Mills was a barrister whose practice was in London. His work involved many human and civil rights cases, and he was a founding member of the National Council for Civil Liberties.

Content: Subject files; personal files; correspondence; desk diaries; files relating to legal cases and chambers business.

**Subjects Covered:**Amnesty International; international human rights work (including in Anguilla, Chile, Egypt, Indonesia, Kenya and Venezuela).

# SPOTLIGHT COLLECTION THE LIBERTY ARCHIVE (U DCL)

(FORMERLY NATIONAL COUNCIL FOR CIVIL LIBERTIES) 1908-1990


Liberty, formerly known as the National Council for Civil Liberties, is a campaign group which has been involved in the safeguarding of civil rights in Britain since its establishment in February 1934. The origins of the group can be seen in the 1932 hunger marches, which took place in protest against cuts to unemployment benefits and the introduction of a means test in Britain. Ronald Kidd was the driving force of the group in the 1930s, aided by Sylvia Scaffardi as the assistant secretary. In the first decade key issues included the fight against fascism, debate over censorship, and the Haworth Colliery Affair.

When Kidd died in 1942, Elizabeth Acland Allen took over as Secretary, and saw the group through WWII. Key issues at this time included defence of dissenters, conscientious objectors, aliens, internees, and press freedom. Following the war, mental health became a significant focus of the group's activities, which contributed significantly to the introduction of the Mental Health Act of 1959.

In 1960, Martin Fnnals succeeded Allen as Secretary, and it was under his leadership that the Cobden Trust was established to undertake research and educational work in the field of civil liberties. Campaigns in the 1960s focused on the defence of minority groups' rights, including black immigrants, children, travellers, reluctant servicemen, and prisoners. The 1970s, 1980s and 1990s saw the defence of homosexual and women's rights, campaigns against miscarriages of justice, and involvement in data protection and privacy debates. Work continues to this day.

Fact: Born 1928, Lubbock (also the 4th Baron Avebury) was a Liberal Party MP. He stood for Orpington from 1962 until 1970, and served as Liberal Party Whip 1964-1970. He undertook a significant amount of work in the fields of human rights and race relations.



# THE PAPERS OF PROFESSOR JOHN SAVILLE, 1850S-2000S (U DJS)

Saville (b.1916-d.2009) was a Marxist historian, member of the Communist Party of Great Britain and the Party's Historians' Group. He joined the Party whilst studying at LSE, where he was taught by Harold Laski. He undertook voluntary work for the Union of Democratic Control, and was involved in the National Unemployed Workers' Movement. He spent WWII in Britain, but was posted to Karachi following D-Day. His final days in India saw the beginnings of the Drigh Road RAF Mutiny and the Forces Parliament at Deolali.

After being demobilized, he was employed at the Ministry of Works, before being appointed to a teaching position at Hull University. Here, he was instrumental in the formation of the Lecturing and Administrative Staff Association, and, alongside John Griffith, he established the Council for Academic Freedom and Democracy. He joined the local branch of the Communist Party and took on responsibility for the Hull branch of the British Soviet Friendship Society. He also ran a series of summer speakers' classes for trade unionists and militant workers, and taught on a North East District Miners' School.

In 1956, Saville, alongside E.P. Thompson, was instrumental in a major rift within the Communist Party, and this led to their resignation and to the formation of the 'New Left' movement. Contention centred on objections to the Soviet Union's invasion of Hungary, and divisions deepened when Saville and Thompson began publishing 'The Reasoner' and 'The New Reasoner' discussion journals. Saville, nevertheless, remained a committed Marxist, never joining the Labour Party. He edited the Socialist Register with Ralph Miliband, and brought to life G.D.H. Cole's vision of a 'Dictionary of Labour Biography' with Dr Jovce Bellamv.




### SPOTLIGHT COLLECTION

Dictionary of Labour Biography, 1816-1999 [U DLB]

**Fact:** The Dictionary of Labour Biography was the brainchild of G.D.H. Cole, and was brought to fruition by John Saville and Joyce Bellamy at Hull University. The original aim of the dictionary was to create biographical entries for all members of the Labour movement, including the rank and file, not just the big personalities





### SPOTLIGHT COLLECTION

Torch, Torchlight and Hullfire Student Newspapers [U SUH/1]

**Fact:** Torch was produced from 1928-1958, Torchlight ran from 1956-1972 and was briefly reprised in 1974, before being replaced by Hullfire.

**Content:** Issues of newspapers produced by Hull Students Union containing poetry; journalism; comment pieces; short stories

**Subjects Covered:** Politics; literature; drama; sit-ins and demonstrations


### SPOTLIGHT COLLECTION

Council for Academic Freedom, 1967-1982 [U DAF]

Fact: Established in 1970 by a small group of academics, prominent early members included John Griffiths, Ralph Miliband and John Saville. The Council was formed to aid individual and institutions facing discrimination or breach of contracts, and for the defence of academic standards in Higher Education

**Content:** Administration files containing correspondence, minutes, annual reports, newsletters, articles and speeches; subject files containing correspondence and press cuttings; institution and individual case files containing correspondence, statements, press cuttings.

**Subjects Covered:** Individual cases; institution cases; conferences; administrative process of the organisation; appointments to posts; dismissals from posts; freedom of speech.

**Fact:** LASA was formed off the back of a campaign to improve library provisions, initiated by John Saville and two other members of staff. The group was concerned with increasing non-professorial staff representation on the university's governance structures.

**Content:** Minutes; committee papers; correspondence; memoranda.

**Subjects Covered:** Meetings; Klingender report on students; University Grants Committee.

# WOMEN IN POLITICS

There are a number of small but important collections within our holdings, which illustrate the variety of ways in which women have been involved in politics in this country. Some collections relate to the struggle for female emancipation and rights, whilst others represent women who have taken up causes and become involved in politics more generally.

### SPOTLIGHT COLLECTION

Julia Varley, 1886-1977 [U DJV]

**Fact:** Born in 1871, Varley was a notable female trade unionist, who served on various bodies, including the General Council of the Trades Union Congress

**Content:** Correspondence; press cuttings; articles; poems; photographs; ephemeral material such as invitations.

**Subjects Covered:** Suffragettes; Women's Social and Political Union; Industrial Welfare Society; trade unionism; imprisonment of suffragettes and suffragists.


# SPOTLIGHT COLLECTION

Rational Dress Movement, 1894-2000 [U DX113]

Fact: Established in 1897, the Western Rational Dress Club was organised by Sydney and Maude Buckman. It sought to highlight the necessity of clothing reform for women involved in cycling, and was part of the wider female emancipation movement.

**Content:** Letters; press cuttings; newsletters; prospectuses; articles. Note that material in this collection consists of photocopies of originals.

**Subjects Covered:** Cost of cycling garments; supporters' meetings; Lady Cyclists' Association; Rational Dress League




Cover of a pamphlet produced by the Equal Pay Campaign, mid 20th cent. [U DCL/16]
